- 3. Yes, it is required and is run via a computerised knowledge test system in the council offices
- 4. Every driver must complete it, so the figure is the same as any figures given in question 1.
- 5. Paid for by the driver.
- 6. At the discretion of Members, currently it is not required other than at initial application unless there are compliance issues during the currency of a licence.
- 7. Drivers must submit pass certificates.
